Auxiliary – Conciliation Committee Checklist

Appointment & Eligibility

- Madam President appoints **five (5) Conciliation Committee Members** at start of term
- Past Madam Presidents prioritized** (if available)
- All members appointed are in **good standing**
- Dual or Dual-Auxiliary members confirmed eligible
- Committee roster remains unchanged unless a **vacancy occurs**

Dispute Filing Requirements

- Dispute occurred **within the past 30 days**
- Member completed **Conciliation Dispute Form** within 30 days of incident
- Form submitted to **Madam President**
- Madam President referred the matter to the **Conciliation Committee**

Meeting & Conciliation Process

- Committee scheduled a **conciliation meeting date for both parties**
- Parties notified of meeting details
- Committee facilitated discussion and offered **resolution recommendations** (no imposed penalties)

Resolution Outcome

If resolution is reached:

- Conciliation Dispute Resolution Form completed & signed by Committee**
- Both parties signed the agreement**
- Resolution Form filed with the **Madam Secretary** and added to Auxiliary records

If resolution is NOT reached:

- Committee completed & signed Resolution Form indicating:
 - Matter dismissed* OR *Formal complaint filed under Section 63.1, Statutes*
- Both parties signed final Resolution Form**
- Final Resolution Form filed with the **Madam Secretary**
- Filing party informed of option to proceed with **Official Complaint through the Aerie Secretary**
